#### 2. Activity of the Civic Association

In 2020, the Civic Association carried out activities aimed at supporting the activities, activities and objectives, in accordance with its statutes, primarily in the form of supporting the educational activities of medical staff of the FDR UGH BB, but also in the form of improving and supporting the quality of health care provided at the FDR UGH BB.

#### **Donations** received

In 2020, the Civic Association received several financial donations from Medtronic Slovakia, s. r. o., one non-financial donation from Johnson & Johnson, s. r. o. and others from private individuals. These financial donations were used in accordance with the purpose for which they were given, as shown in the summary below.

**Company Medtronic Slovakia, s. r. o.** made financial donations to the civic association in the total amount of  $4,923.9 \in$ , for the purpose of supporting the participation of FDR UGH BB medical staff in educational events.

**Company Johnson & Johnson, s. r. o.** donated an in-kind donation of 350 respirators to the civic association for the purpose of providing PPE to medical staff.

Mr. M.P. donated funds to the civic association to improve the quality of health care in the amount of  $1,507 \in$ .

Mr. **F.T.** donated funds to the civic association for the improvement of health care in the amount of  $1,507 \in$ .

Ms. J.O. donated funds to the civic association in support of FDR UGH BB in the amount of 197 €.

#### Other income

In 2019, the civic association successfully applied for registration in the "List of recipients of 2% of taxes" for 2020. From the donated 2% of the tax, or 3% in the case of legal entities, the civic association received funds in the total amount of  $9,661.89 \in$ .

#### Support of FDR UGH and medical staff

Thanks to the funds provided to the civic association, the civic association supported with a financial donation of  $2,270 \in$ , publication of a scientific article "Adherence to oral nutritional supplements after being discharged from the hospital is low but improves outcome in patients with advance chronic liver disease Open Access" in an indexed scientific journal Patient Preference and Adherence.

In 2020, the Civic Association also contributed to improving the quality of health care provided at FDR UGH with a financial donation of  $3,800 \in$ , granted for the purchase of a continuous passive motion shoulder machine for rehabilitation purposes.

The civic association released from its funds to the FDR UGH BB the amount of  $1,100 \in$  for the purpose of reimbursing the costs of the implementation of an educational activity for medical staff of the FDR UGH by experts from IKEM. For the purpose of supporting medical staff, the FDR UGH BB

civic association provided funds in the amount of 907  $\in$  for the purchase of computer equipment for the Organ Procurement and Transplantation Database Unit.

Funds were released by the civic association in the amount of  $500 \notin$  for the purpose of reimbursing the training costs of MUDr. M.U., Head of the Department of Pneumology and Phthisiology in the field of medical management and financing.

On the microbial transplantation project implemented by II. Internal Clinic of SMU FDR UGH BB for the examination of the microbiome in the intestine using the 16S-RNA methodology, OZ paid to M.K. the amount of  $210 \in$  and A.R. the amount of  $45 \in$  on the basis of the Contribution Contract.

The Civic Association has released from the funds an amount of  $600 \notin$  for the purpose of processing statistical analyses for HEGITO.

The financial support received from Medtronic Slovakia, s. r. o. provided funds in the amount of 1,623.30 € to MUDr. K.P. for the purpose of attending the neurosurgical congress in Sarajevo.

The registration fee for 2020 for the European Society for Organ Transplantation ESOT Foundation was paid from the funds of the civic association in the amount of 500€.

Of the additional funding of  $251 \notin$  the educational event Nerve-sparing robotic-assisted radical prostatectomy was supported and in the amount of  $1,500 \notin$  technical provision of video transmission at the Urology Workshop was ensured.

#### 3. Management of the Civic Association

At the beginning of the accounting period, on 1 January 2010, the civic association had financial resources in the total amount of  $18,405.6 \in$ . The Civic Association had no receivables or loans at the beginning or end of the 2020 financial year.

The balance of the civic association's funds as of 31 December 2020, at the end of the accounting period, was in a monetary institution in the total amount of  $22,605.06 \in$ . The balance of the funds of the civic association as of 31 December 2020, in the treasury, was in the total amount of  $36.24 \in$ .

The income of the civic association in 2020 income from legal persons, in the form of financial donations, and a substantial part of the income was also income from remittances of 2% of the tax, or 3% in the case of legal entities. The total income for 2020 was in the amount of 17,796.80 €.

Expenditure of the civic association in 2020 totalled  $13,561.10 \in$ . From this amount, the funds were used for the activities mentioned in point 2. Activities of the civic association, namely to promote and improve the quality of health care provided at the FDR UGH BB, and to support the education of health care workers at the FDR UGH BB. Expenses of an amount of  $253.30 \in$  were used to cover the operating costs of the civic association, in particular rent, notary fees and administrative costs.
